We are fast approaching our April semi-annual SWW Homeowners Association meeting scheduled at 7 p.m. on Thursday, April 19th at the Hy-Vee upstairs meeting room. This is our non-voting meet. However, many important topics will be discussed in preparation for the October annual meeting that is our voting meeting.

We will share the latest update on the Wanamaker road construction; hear from our Landscape committee on the progress of our circles and entrances; review a few possible updates to our covenant restrictions and give you dates for neighborhood meetings to gather your input; review possible updates for the SWW Homeowners Association bylaws; receive the Treasurer's report on the financial status of our Association and last but not least, find out about what is happening from our Social committee.

Since springtime is when many of us start to think about making changes to our house, fencing or vard, please make sure that you refer to our SWW covenant restrictions before you do any project that affects the outside of your home or yard. The covenant restrictions apply to all homes/lots in SWW. They are posted on our web site: www.shadywoodwest.org . You may also request another copy of them from Becky Stauffer, our Block Captain Coordinator. Our Architectural committee should be contacted to ensure that your proposed changes comply with the covenant restrictions. The committee members are listed in the front of your SWW Directory and on the web site under contacts. Please remember that the wisdom of having these restrictions from the inception of SWW was not to overly restrict what can or cannot be done on our properties, but to have reasonable restrictions that help to protect the high quality appearance of our homes over time.

I hope to see everyone at the meeting on Thursday, April 19th – 7 p.m. at the Hy-Vee upstairs meeting room.

October Meeting Minutes

The meeting was called to

order by President Lisa Stubbs at 6:00 PM in the HyVee meeting room. About 26 neighbors were present. The agenda was adopted and was approved by a voice vote. The minutes from the previous meeting were also read and approved. President's Report: There have been a lot of home invasions in Topeka. Please keep your home well lit. Replace burnt out light bulbs. Please ask a neighbor to watch your house if you know you will be out of town. Do not open your door to people that are unfamiliar. Treasurer's Report: We have \$33,500 in the bank. we have 90% of the neighborhood paying their dues! We were about \$4,500 under budget this year. Social Committee Report: We had another successful Shadylady breakfast. About 14 people went to Paisanos on the 15th. December 1, 2011 is our special night at the Top of the Tower. Grounds Committee: We did not water this year. Committee members did clean up, trim and weed. Mulch was not replaced. There

are a large number of people volunteering to help. The entrances and traffic circles are a primary concern. committee has secured plans for renovating these areas from a professional horticulturalist from Skinners. grounds committee will oversee these changes and will be available to maintain the changes. The changes will proceed in two stages. In this budget year, the 3 traffic circles will be completed. The entrances will occur in the next budget. Demolition will occur this year. The three circles and 37th street entrance will be cleared down to the bare ground. This will be hired out. The electrical system needs to be revamped in order to install new lights and lamps. This part of the plan should be completed by December 1. Planting in the circles will proceed in April. Planting on 37th will wait until construction is complete. A lot of thought, time, and hard work had been put into this plan. Please thank Jane and her committee if you see them. **Budget Adoption:** The 2011-2012 budget was approved by a voice vote.

Other: Wanamaker Update: The work on Wanamaker will proceed in 3 phases. It will begin this November and be complete by December 2012. There will be public meetings. More information should be coming from the city. We will try to organize a meeting which will focus on just our neighborhood.

Treasurer's Report by Mark A. Burghart

The Shadywood West Homeowners' Association had a balance of \$39,074.44 in its checking and savings

accounts on March 1, 2012. Since October 1, 2011, the Association has collected \$11,300 and spent \$5,406.50.

As you might expect, most of the Association's expenses will be incurred during the spring and summer

months. Dues are primarily used to fund the mowing of the common areas, the maintenance of the traffic

circles and the payment of utilities. Total budgeted expenditures for these services this fiscal year amount to

\$7,000.

Current dues and reserves also will be used this year to pay for major renovations to the traffic circles

which projects are ongoing. The total budget for these projects is \$22,000.

One hundred and thirteen (113) homeowners have paid their dues for the current fiscal year which

extends from October 1, 2011 through September 30, 2012. There are 17 homeowners who have not yet paid

their dues. Earlier this year, a second reminder notice was mailed to those who have not yet paid. A color-

coded map on the Association's website shows current members. The map will be updated soon. The

Association's By-Laws provide that current dues must be paid to be considered an Association member. Please

call me if you have any questions regarding your payment status.

Landscaping Update

The landscape renovation plan is on schedule! A summary of our progress is as follows:

*The traffic circles will be planted this spring. Initial demolition began last fall; the final phase of demolition and plant bed preparation is anticipated to begin any day as weather permits. Planting of shrubs, trees and perennials will follow. Installation of an updated, water-conserving irrigation system will be completed after planting is finished.

*The new electrical posts where needed, new lamp posts and heads were installed in November.

*The entrance at 37th and Stonybrook will be in progress through the fall, 2012.

*Planning on the 34th Terrace/Wanamaker entrance will begin this spring with implementation anticipated in Spring, 2013.

If you wish to review the Landscape Renovation plans that were approved last fall, please visit the SWWHOA website. Plans and narratives are all posted there.

On the Drawing Board

The Wanamaker Road improvement and subsequent construction will significantly impact the 34th Terrace entrance and will require extensive cooperative and collaborative planning with affected residents and neighbors. That process will begin this spring. Information and notifications will be communicated on the SSWHOA website, via e-mail or printed door-to-door notices.

Future Considerations

The disposition of the fence on 34th Terrace will be discussed –hopefully before a strong wind or storm forces the issue. Members of the association are respectfully requested to inform the board or the grounds crew of other matters that may need attention.

As the traffic circles are completed and as all of the beautiful and extensively landscaped areas in neighbor's yards emerge, please kindly respect and acknowledge those efforts by **curb**ing **your pets**.
